

PRIVACY POLICY AND DATA PROTECTION (hereinafter the "Policy") COLEGIO DEL VALLE, SOCIEDAD ANONIMA, legal entity card number: three-one hundred one- zero nine six one six five , domiciled in San Jose, Escazú, Guachipelín, 1.2km northwest of the former Multiplaza roundabout (hereinafter the "Responsible") informs you that according to the Law of Protection of the Person against the use of your personal data No. 8968 (hereinafter, the "LPD") and its Regulations, informs the user of the existence of a Personal Database created by the Responsible, and called "BVSGeneral".

PURPOSE OF DATA COLLECTION

The data that the user provides to the Responsible is collected for informational purposes to provide a service, maintain contact, send informational pieces and organize all kinds of activities. This information will be treated in accordance with the reservation, confidentiality and security stipulated by the legislation in force in the matter in Costa Rica. It may also be used to send information about the services provided by the Responsible that may be of interest to you, as well as marketing and advertising material.

OF THE IDENTITY OF THE REGISTERED USER, VERACITY AND ACCURACY OF THE INFORMATION PROVIDED

You as a user, or on behalf and authorized by another, or on behalf of a minor that comes to school at Colegio del Valle state that you are the one who claims to be you or the person or the minor represented, and state that the information that you enter in the school's system is truthful and accurate. You also assume the obligation to make the necessary information updates to keep it clear and accurate at all times. If you fail to comply with the obligation to update, you as a user exempt Colegio del Valle from any legal consequence regarding these elements of authenticity and accuracy corresponding to the principle of quality of the information established in the national legislation.

On the other, if the Responsible were to establish that you have entered information in a way that is contrary to what is indicated in the previous paragraph, it will immediately proceed to eliminate it. All of the foregoing, without prejudice to the possibility of taking legal actions that are necessary to protect the rights of Colegio del Valle or any third parties that have suffered damage as a result of the violation you have committed

OF THE QUALITY OF DATA AND REVOCATION OF CONSENT

The data requested is appropriate, pertinent and not excessive. However this, you may or may not voluntarily provide data that is not strictly necessary for legal purposes and having given your consent to proceed with the treatment of the data. This consent may be revoked at any time in person at the address indicated above, or by sending a communication to the email address datos@bluevalley.ed.cr.

Notwithstanding the above, the Responsible must keep the data as backup of the service provided and/or for legal obligations. As well, in some cases it will be necessary to send the data to other institutions like the Ministry of Education or to similar institutions that request it.

OF THE COLLECTION OF OTHER INFORMATION

Besides the information that you provide us, the Responsible informs you that it may gather other information from public databases, in which case this data will only be used for internal purposes. It will also access information through the use of cookies in the web page <https://www.bluevalley.ed.cr>.

In view of the above, we inform you that you can prevent the Responsible from picking up your behavioral information whilst using its Web Page by configuring your browser in a way that it does not allow the use of cookies when visiting the Responsible's Web Page.

Also, when you enter the Responsible's premises, there may be surveillance cameras that record the images they capture at that time. The data obtained from these cameras will be used for security and disciplinary purposes only.

Colegio del Valle will never request information of a financial type or identified as 'sensitive' by the data protection regulation of the person, therefore, if you receive a communication identified as from "Colegio del Valle" requiring this type of information, do not respond, proceed to delete it and immediately inform Colegio del Valle about it.

As an exception to the above paragraph, there is that information that will be necessary to collect to protect the health of students and other members of the institution. In this regard, health-related information may be collected for the purpose of knowing possible allergies, the treatments that the Responsible's health personnel are giving, to provide support on the psychological side, among others. In any case, the handling of sensitive data will be carried out as indicated by the LPD by personnel subject to professional secrecy and/or an obligation of equivalent confidentiality.

In addition, in case you wish to request any special attention for the students of the Responsible, in the happening of a religious event, it will be necessary for the Responsible to have access to sensitive information about the religion of the persons attending the institution.

CONSEQUENCES OF THE NEGATIVE TO SUPPLY DATA

The consequence of not providing the data or of denying consent at any time for its treatment, will be the impediment of the Responsible to contact you for any intended purposes.

OF THE RECIPIENTS OF INFORMATION

In principle, the data that the users provide will not be released, communicated or transferred to a third party. In case of a special situation in which some personal data should be provided to a third party in accordance with legal procedures, the user will be notified first and asked for his/her consent.

OF THE USERS LEGAL AGE

Due to the nature of the Responsible, the data of the children under age will be included in the General database, therefore, if you are under fifteen you are committed to request your

parents/guardian consent prior to including any type of information of yourself in the different Responsible's data collection systems.

Without limiting the foregoing, minors are prohibited, even with the consent of their parents/guardians, to include any kind of information that: (i) is considered sensitive data by the LPD, or (ii) personal data of their parents or guardians and that is not exclusively contact information to verify the authorization mentioned in the previous paragraph.

OF THE RIGHTS THAT ASSIST YOU

You may exercise your right to accessing, rectifying, modifying, revocation and/or elimination of the treatment of your personal data by presenting a written communication to the Responsible at the physical address indicated, or sending an email to datos@bluevalley.ed.cr

OF THE SECURITY LEVELS

The personal data of our users is stored in a database owned by the Responsible that guarantees the appropriate technical and structural measures to guarantee the integrity and security of the personal data provided in accordance with the current technical status of the Law of Protection of the Person against the use of personal data No. 8968, and its Regulation No.37554 -JP published March 5, 2013 in *La Gaceta* n 45 de 05, without prejudice to inform you that security measure on the Internet are not infallible.

REGARDING COMMUNICATIONS WITH THE USERS

The treatment of personal data and the communications sent via electronic means are in accordance with the LPD legislation and its Regulations. At the time of including your information through any of the means that Colegio del Valle has available for you for this purpose, you authorize Colegio del Valle to send you communications, guaranteed that in every electronic communication sent you will be informed about your right to oppose to continue receiving communications.

Without limiting the foregoing, users who request it may dispense with this service easily, free of charge, presenting a written communication to the address previously indicated or sending an email to datos@bluevalley.ed.cr.

APPLICABLE LAW AND JURISDICTION

This Privacy and Data Protection Policy is governed by the law of Costa Rica. The parties submit to its administrative system, courts and tribunals. All shares of Colegio del Valle, Users, or General will be considered to have been made in Costa Rican territory for any legal effect. This Private and Data Protection Policy is governed and construed in accordance with Costa Rican legislation in what is not explicitly established.

ACCEPTANCE OF THIS POLICY

You agree to this policy by checking the box next to “I have read and accept the Privacy and Data Protection Policy”, found in the form for collecting data. Therefore, we recommend that the user reads this policy carefully before checking the box.
